**Whereas**

- the Reach Italia Onlus has the role of an Italian Lay Institution, independent and legally recognized from the Italian State, and operates for an appropriate schooling of the most needy children, helping destitute kids with the system of the sponsorship at distance;
- the Reach Italia Onlus has chosen, for many reasons tied to its history and to the local reality *(indicate the country or the project)* .....

- the Reach Italia Onlus works at a local level, directly or through fiduciary charitable institutions.

**Declares**

1. to accept without any reserve the statutory rules and regulations of Reach Italia Onlus of which it is fully aware of, and also to accept its subsequent amendments to be announced through the following internet address [www.reachitalia.it/aspettigiuridici.htm](http://www.reachitalia.it/aspettigiuridici.htm) that will be effective starting the financial year subsequent to the publication;
2. to accept that all expenditures to manage the schooling project will be proportional to the real forces and resources involved;
3. that it is only up to Reach Italia Onlus to take any decisions for the managing of its own funds through the approval of an appropriate budget for the expenditures and prospective investments;
4. that no actions tending to damage Reach Italia Onlus' interests will be carried out and that the reports for the management of the schooling projects will always be based upon ethical foundations and maximum transparency;
5. that Reach has the faculty to discontinue the transfers of funds to our institution in case we will not comply with statutory norms and/or regulations that are the ground of this letter of purposes. Besides, we take cognizance that, as regards the availability of funds, Reach Italia Onlus depend on its donors; therefore, though they manage according to a wise estimate of receipts, they cannot mathematically guarantee that the amounts they intend to allow to a country are always available anyway;

6. that Reach Italia Onlus has the faculty to operate also directly in the country if this should be necessary to improve the efficiency of the project, so that the aids to children will not be discontinued;
7. in case, for any reasons, our institution should decide even unilaterally to disengage from the management of the schooling project, we shall have to put in action all the necessary measures to safeguard the interests of the sponsored children and the continuity of the project, by facilitating the direct intervention of Reach Italia Onlus itself or through another organization independently selected by Reach.;
8. to take cognizance that, as for the investments, the specific letter-agreement enclosed is a component part of the present letter of purposes;
9. that in observance to the Italian legislation in force as regards the secrecy of data, we accept the responsibility to treat all the data Reach Italia Onlus passed on to us, only in the aim to carry out the institutional activities.

We feel confident that the norms and principles listed in the present letter will be the ethical ground for a solid, durable and satisfying co-operation between our institutions,
